(NOTE: RIDERS CANNOT BE ACCEPTED FOR LESSONS UNLESS THEY CARRY APPROPRIATE MEDICAL INSURANCE)

LESSONS: Each lesson will be approximately 30 minutes long. Riders who are physically capable may participate in the grooming and/or saddling of his or her horse. The capability will be determined solely by the instructor.

PAYMENT POLICY: The cost of the riding lesson is \$35.00 per lesson. Payments are due at the time of the lesson. Lessons may be paid in advance for one month at a time. Lessons are held once per week. Checks for lessons should be made payable to In-Stride with Therapeutic Riding, Inc.

CANCELLATIONS/RESCHEDULING: In-Stride will make every attempt to reschedule lessons cancelled by In-Stride. Fees prepaid for lessons cancelled by In-Stride that are unable to be rescheduled will be credited to the next months account balance. In the event that a Rider must cancel or reschedule a lesson, he or she agrees to make every effort to give In-Stride at least 48 hours prior notice. If a Rider misses a lesson without giving In-Stride notice, Rider will be responsible to pay the cost of the lesson and, unless prepaid, will be billed accordingly for said lesson. If a Rider misses 3 lessons without notice, Rider will forfeit his or her spot in the therapeutic riding program. Lessons due to illness, vacations or otherwise may be rescheduled during weeknight session times.

CANCELLATION DUE TO INCLIMATE WEATHER: For the safety of our Riders, Volunteers and horses, lessons will be cancelled due to the following weather conditions: (i) temperature of 94 degrees with high humidity; (ii) thunder and severe showers; or (iii) snow accumulation.

INDEMNIFICATION: Rider agrees to indemnify, defend and hold harmless In-Stride with Therapeutic Riding, Inc. and Micky and Ben Cogley (property owners), and its respective employees, agents and representatives, from and against all claims, demands, causes of action, losses, costs and expenses (including reasonable attorney's fees) (collectively "Losses"), arising in favor of any person on account of or as a result of (a) the negligence or willful misconduct of Rider, or (b) bodily injury and property damage resulting from an incident due to Rider's involvement with In-Stride Therapeutic Riding, Inc.; provided that Rider shall have no liability for Losses resulting from the sole negligence of In-Stride with Therapeutic Riding, Inc. and/or property owners.

TERMINATION FROM LESSONS: A Rider may be terminated from lessons at any time at the sole discretion of In-Stride with Therapeutic Riding, Inc. for behavior that results or may result in injury to any volunteers, other riders and/or horses. A Rider may also be terminated from lessons if it is deemed by In-Stride, therapists or the treating physician of the Rider that the therapy is causing more harm than good to the Rider's present medical conditions.

This Agreement may be terminated by either In-Stride with Therapeutic Riding, Inc., its agents, employees and representatives or the Rider by giving thirty (30) days written notice that participation is no longer desired.
